- Sign in crew members for races up to 6 times per year per person
- Sub Category Junior A - 18-24 on 1st January
- Sub Category Junior B – 25-29 on 1st January
- Sub Category Senior over 65 – must have been an SLYC member for a minimum of 5 years
- Sub category Senior over 75 – must have been an SLYC member for a minimum of 10 years
